# **TERMS OF USE – Controller Data**

(Last updated: 27 March 2023)

# **INRODUCTION**

These Terms of Use ("**Terms**") apply to your access to and use of data collected from connected climate and irrigation control devices ("**Controller Data**") labelled and/or that have been marketed by Munters Israel Ltd or any of its affiliates, which Controller Data is made available to you through Munters Israel Ltd's cloud services, and constitute a binding contract between you, duly acting on behalf of a corporation or other legal entity, and Munters Israel Ltd ("**Munters**", "we", "us", or "our").

Munters grants you the right to use the Controller Data pursuant to these Terms (as amended from time to time) and any other applicable terms included or referenced herein or in connection with the provision of the Controller Data. You accept these Terms when prompted in connection with the setting up of your access to the Controller Data. If the Terms are not accepted, the Controller Data will not be made available to you.

By continuing to access and use the Controller Data after an update to these Terms, you acknowledge your full understanding of and accept the updated Terms.

The termination of the Terms is subject to the termination provisions provided for herein.

If you choose to terminate the Terms, Munters is entitled to, in its sole discretion and without giving any prior notice to you, disconnect your access to the Controller Data.

# **LICENSE**

By accepting these Terms in accordance with the above, we grant you a non-exclusive, non-transferable, non-sublicensable, personal, limited, revocable license to use the Controller Data on the terms and conditions set out in these Terms ("**License**").

#### USE OF THE CONTROLLER DATA

Access to the Controller Data is solely intended for commercial use, to the exclusion of any private use. You agree to only use the Controller Data in accordance with these Terms for lawful and reasonable purposes, such as:

(a) understanding the climate and animal status in each farm;

- (b) adapting the operations based on data (e.g. bin feed refilling, animal pick up for processing, etc.);
- (c) evaluating the intervention of supervisors in case of anomalous situations;
- (d) running analytics to compare the performance of different farms; and
- (e) other activities compatible therewith.

In addition to any other user restrictions as provided for under these Terms and except as expressly permitted under these Terms, you shall not:

- (a) override any security feature or circumvent any access controls or use limits of the Controller Data or the cloud services:
- (b) violate the intellectual property rights or other rights of Munters;
- (c) rent, lease, sub-license, loan, distribute or sell/re-sell the Controller Data;
- (d) incorporate the cloud services or the Controller Data with any other programs; and
- (e) make alterations to, or modifications of the whole or any part of the cloud services or the Controller Data, or disassemble, decompile, reverse-engineer or create derivative works based on the whole or any part of the cloud services or the Controller Data.

# SERVICE AVAILABILITY
